At any time before the levy of real property, payment of the tax with surcharges, interest and penalties may be made. The delinquent taxes shall be subject to payment interest at the rate of two percent (2%) per month or a fraction thereof from the time it is due or upon the expiration of the periods for payments provided in the Local Government Code until the same is fully paid, provided, however, that in no case shall the total interest on the unpaid tax or portion thereof exceed thirty six (36) months. Further and unless the surcharges and penalties are paid on or before October 6, 2011, except when the Notice of Assessments or special levy is contested in accordance with the proper procedures provided by law, the delinquent Real Property will be sold at public auction and the title to the property will be vested in the purchaser or forfeited in favor of the City should there be no purchaser, subject however, to the exercise of the right of redemption granted by law unto the delinquent owner of the property or any person having legal interest therein.

Personal property may be distrained to effect, and/or levy upon the real properties of the delinquent tax payer to satisfy the delinquency.
