CONTRACT PERIOD : A – B September 1 to December 2011

Prospective bidders should be undertaking a similar project within the last five (5) years in any local government unit.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary “pass/fail” criteria as specified in Republic Act No. 9184 and its Revised Implementing Rules and Regulations (IRR).

A complete set of Bidding Documents may be purchased by interested Bidders from the Bids and Awards Committee Secretariat upon payment of a non-refundable fee (“Fee”) of ten percent (10%) of one percent (1%) of the ABC but not less than One Thousand Pesos (P1,000.00).

The Eligibility Statement and Screening, Bid Security, Performance Security, Pre-Bidding Conference(s), Evaluation of Bids, Post-Qualification and Award of Contract shall be governed by the pertinent provisions of R.A. No. 9184 and its Revised Implementing Rules and Regulations.
